Purpose Of This Document

The purpose of this policy is to:

1. Describe how Rainier Guard (vRG) vSOA collects and uses personal information.
2. Comply with the VATSIM Special Operations Policy.
3. Comply with the Safeguarding of Minors Policy.

Applicability

This policy applies to any current or former vRG member or any member who has applied to vRG.

Data Collection and Use

Rainier Guard does not sell, share, or rent personal information to others and all personal information is contained within the Rainier Guard organization.

The information we collect from you is:

- Full Name
- Email Address
- IP Address
- VATSIM CID
- Discord Username

By joining Rainier Guard through our Discord you are agreeing to Rainier Guard collecting your data as listed above and its use by Rainier Guard staff as needed for management of the organization. We use the information listed above to create your pilot profile.

VATSIM User Rights

Rainier Guard is a VATSIM Partner and therefore will comply with all applicable VATSIM User Policies.

As a VATSIM user, you have a number of rights, including but not limited to:

- A right to be informed about why we collect your data.
- A right to access your data and view the data we have collected on you. This data will be released to you upon written request. To protect the privacy of VATSIM staff members, the names of individual staff members making entries on your record and other security measures may be redacted.
- A right to rectify data you believe to be inaccurate.
- A right to request your personal data be erased from Rainier Guard. This will result in the termination of your membership from Rainier Guard.

Data Retention

Rainier Guard will retain the information you submit during your initial application to aid in re-application or to prevent members who have been permanently removed from Rainier Guard due to policy breaches.

Cookies

Rainier Guard may use cookies on our website(s). A cookie is a piece of data stored on your hard drive which is used to track you through our site and for network security. Rainier Guard has no access to or control over these cookies.

Use of Other Sites

Rainier Guard may from time to time utilize other services to gather data such as Google Forms, Google Drive, or similar. These other sites may have their own data retention or privacy policies, and the data that Rainier Guard obtains and stores on these sites remains within that domain and is not shared elsewhere.
